My dear Professor Simonsen,

I am much obliged to you for sending me your interesting Paper on Maimoniana. I have not yet seen Dr. Poznanski's Babylonische Goenim. The Nasi Hodia Benjesse is however not so unknown.

You will remember that in the R.E.J. in my Italian fragment I refer to the name Hodia.

I find that I have a fragment in which occurs the name of the Nasi Hodia ben Nasi Solomon, a contemporary of Abusa'd ben Methaneel. He may be the Uncle of the Nasi Hodia Benjesse mentioned in the Tachkemoni (see the enclosed Pedigree from the Tachkemoni with my additions.)


He is hardly likely to be the Hodiah who is the first name mentioned after Zerubabel in that Pedigree.

I find also among my notes a reference to a Nasi Hodiah whose name is spelt as in 1 Chronicles 3-24 (Keri) of the royal house there described.

I have sent you a copy of my Paper about the Hebrew Treasures of England which may interest you.
